Letter To Our Members

As a cooperative, our business model is different from that of for-profit corporations. Dakota Electric is owned by those who purchase electricity from us, meaning you are the reason we exist. We focus on providing reliable electric service at reasonable rates, and any profits from the business are eventually returned to members. In 2009, we returned more than \$1.3 million in profits to members who purchased electricity from us in 1981.

A board of directors, comprised of member-owners like you, governs Dakota Electric and its \$270 million in assets. Each member has an opportunity annually to vote for board members who approve budgets, policies and rate structures.



One of the many decisions carefully examined in the boardroom is the need and timing of rate increases. Dakota Electric currently has a rate increase request before the Minnesota Public Utilities Commission. As labor and material costs increase, the current rate increase will ensure that Dakota Electric has the capital necessary to maintain the power lines and equipment needed to deliver reliable electricity while meeting financial targets required by lending institutions. We don't increase rates to boost shareholder value. Still, we understand that cost increases impact you, and in preparing our 2010 budget, we made hard decisions and made cuts as long as they did not impact reliability, safety or customer service.

Dakota Electric's expenses account for approximately 30 percent of your bill. The other 70 percent of your bill pays for wholesale power and transmission services from Great River Energy, which also made hard decisions and eliminated a large projected wholesale rate increase for 2010. Great River Energy and Dakota Electric are working hard to limit future increases, but infrastructure needs and increasing material and labor costs may continue to put upward pressure on prices. Legislation being discussed in Washington D.C. and St. Paul could affect future rates as well, and we are working to help lawmakers understand how legislation will impact the price you pay for electricity.

As a member-owned cooperative, we look out for our members. And while we may not be able to eliminate every future increase, we want to help you manage your electric use to minimize the impact on your bill. We offer more than 50 programs to help members save money, and our Energy Experts® are available to help you make wise energy decisions and provide energy-efficiency ideas for your home, business or farm.

We hope you take the time to review this issue of *Circuits*, and don't hesitate to call with questions or comments.

Year in Review



Surpassing service and reliability goals

As a member-owned cooperative, we strive to provide quality service to our member-owners. Below is a brief overview of our 2009 achievements.

- >> Helped members conserve more than 18 million kilowatt-hours (kWhs) of electricity, which is enough energy to power more than 19,000 homes for an entire year.
- >> Reduced our wholesale power bill by more than \$15 million through member participation in EnergyWise® off-peak programs.
- >> Exceeded goals reported to the Public Utilities Commission:
 - Outage duration averaged less than one-half hour per member per year.
 - Outage frequency per member averaged less than one outage every two years.
 - Power available more than 99.99 percent of the time.
 - Member service representatives received 162,772 calls in 2009 and answered 94 percent of calls in 20 seconds or less.
 - Meter readers completed more than 1.3 million meter readings, estimating less than one percent of all readings.
- >> Awarded nearly \$25,000 in scholarships with unclaimed capital credits.
- >> Upgraded River Hills substation in Eagan to improve reliability.
- >> Completed a study to identify future upgrades that will improve reliability.
- >> Scored an 83 on the American Customer Satisfaction Index, which is significantly higher than the utility industry average of 73 points.
- >> Rolled out the first phase of our geographical information system (GIS) upgrade, which integrates digital maps, member databases, outage management and other systems to provide employees access to more real-time information. This project will help improve member service, reliability and the efficiency of your cooperative.

2010 Goals

Efficiency

- Encourage residential members to conserve more than 3.6 million kWhs of electricity through appliance rebates and other programs
- Offer rebates and grants to urge business members to conserve more than 14.6 million kWhs

Reliability

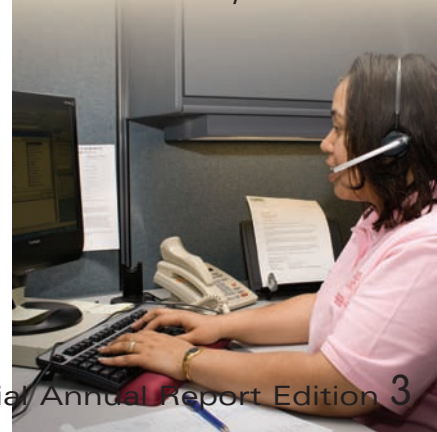
- Complete two substations and begin construction on a third
- Upgrade 12 miles of underground power lines

Affordability

- Work with our wholesale power supplier, Great River Energy, to minimize power cost increases
- Educate legislators on the impact legislation will have on Dakota Electric members

Community

- Support local economic development efforts to promote high-tech infrastructure and produce business and job growth
- Educate more than 4,000 students and adults about electrical safety

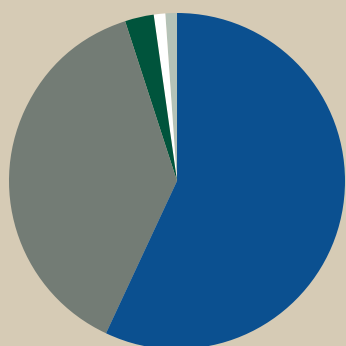

■ Street lighting - 1%

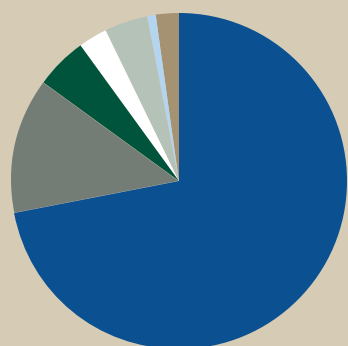

Rate Case Update

ADMINISTRATIVE LAW JUDGE DRAFTING RECOMMENDATIONS

The Administrative Law Judge is currently developing recommendations for the Minnesota Public Utilities Commission's ruling on Dakota Electric's rate case. The Administrative Law Judge makes her recommendations based on information collected during the rate case process from state agencies reviewing the rate case, Dakota Electric and members.

The Minnesota Public Utilities Commission will review the recommendations and make a final decision on Dakota Electric's rate case in mid-2010.

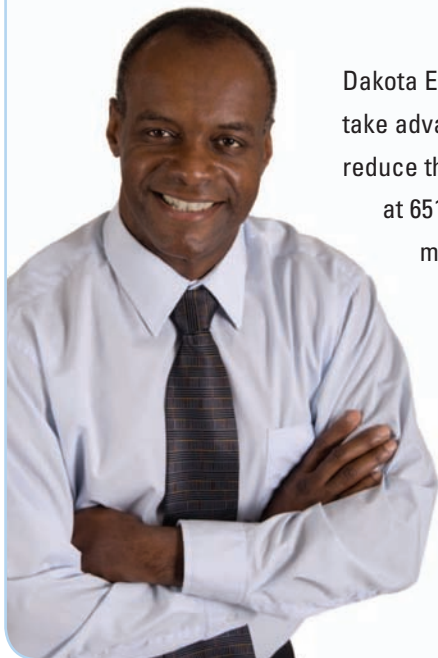
