Important:

- Rebate amount is up to \$500 to offset the cost to install an EV charger controlled on an off-peak rate.
- EV charger must be installed within Dakota Electric's service territory.
- Additional outlets for your EV that are not off-peak outlets are prohibited when participating in the storage program.
- Fill out this form completely. Incomplete forms will not be processed.
- Include your account number and sign the form.

Five Steps to receiving an EV Charger Installation Rebate

1. Pick your charging program

Members must enroll in one of Dakota Electric's Charge Wise® off-peak vehicle charging programs to receive the charger installation rebate. Members can choose the best option for their charging needs, either the storage rate or time-of-use rate. 2. Order the submeter socket

Call Dakota Electric at 651-463-6243 to order the submetering equipment for your project. The equipment is determined by which charging program you choose and billed to accounts in good standing. It can be picked up from our office in Farmington or delivered to your home.

- a. Equipment for time-of-use rate: \$50 plus tax
- b. Equipment for storage rate: Call our Energy Experts® at 651-463-6243 to determine which storage setup will deliver you the most savings.
 - i. Multi-load setup: \$110 plus tax
 - ii. Single load setup: \$50 plus tax

3. Get estimates

Request two-to-three estimates from electricians to install a dedicated EV circuit and off-peak submeter socket. Our \$500 rebate is designed to cover at least 50% of the wiring cost for an average project. Project costs vary based on the capacity, age and location of your home's electric service.

4. Schedule installation of your submeter

After the circuit and submeter socket are installed and an inspection is complete, you or your electrician should call Dakota Electric at 651-463-6243 to schedule installation of the submeter. In some cases, this requires a homeowner to be present for about 15 minutes. You are not enrolled in a charging program until the meter is installed.

5. Submit your rebate application

After the submeter is installed, submit your Dakota Electric equipment invoice and the electrician's invoice with the EV rebate form (on reverse side) for your rebate of up to \$500.

Power your EV with 100% wind energy, for the life of the vehicle, at no extra cost by signing up for Revolt. Submit a copy of your dealership invoice or vehicle title with your Revolt application (available on our website) to Dakota Electric and we'll send you a confirmation packet.
