Please read and follow voting directions carefully. If you inadvertently vote both by paper ballot and online, only the paper ballot will be counted.

Voting by mail. If you choose to vote by mail, insert your completed ballot into the white Ballot Secrecy Envelope and seal the envelope. Insert the sealed Ballot Secrecy Envelope into the green Business Reply Envelope. Tear off and discard the address stub on the back of the green Business Reply Envelope. Seal and mail the green Business Reply Envelope.

Voting online. If you choose to vote online, go to www.dakotaelectric.com. You will need your Account Number and Election Passcode found on the backside of the enclosed green Business Reply Envelope. Or, scan the QR code near your Election Passcode with a mobile device to be quickly logged in to vote. Then simply follow the instructions given on the website. In the past, many have found online voting to be very quick and easy.

Ballots must be received at Survey & Ballot Systems, an independent election service, no later than noon on April 25, 2019. Please do not enclose any other correspondence to Dakota Electric Association with your ballot. As an option, your ballot may be submitted in person at the annual meeting. Be aware, however, that you must bring the enclosed ballot to the meeting in the envelopes provided because you will not receive a second ballot at the meeting. The annual meeting starts at 7 p.m. on April 25, 2019, at St. Michael's Catholic Church, 22120 Denmark Ave, Farmington, MN 55024.

2019 Director Candidate Profiles District 1



David Jones, Lakeville, is the incumbent seeking re-election in district 1 and a 24-year member of Dakota Electric. Jones is currently board chair, serves on the Audit Committee, as an officer of Midwest Energy Services Board and its subsidiary boards and is a voting

delegate to the Cooperative Finance Corporation. He is a member of the Minnesota Rural Electric Association, the Institute of Electrical and Electronics Engineers, and the Society of Logistics Engineers. He has a Bachelor of Science degree in electrical engineering from North Dakota State University and an MBA from Pepperdine University. His experience includes high-reliability electrical systems and more than 27 years of technical management experience including at both Lockheed Martin and UTC (Goodrich/Rosemount) Aerospace.

District 2



Jim Sheldon, Apple Valley, is the incumbent seeking re-election in district 2. He served as board chair from 2007 to 2018. Sheldon is currently board treasurer, chairs the Audit Committee and serves on the Midwest Energy Services Board. He

is a retired attorney. He served as the Apple Valley and Eagan city attorney and has served as a court appointed Condemnation Commissioner in Dakota and Carver counties. He has served on the Dakota County Technical College Foundation Board, Community Action Council Board, Prince of Peace Lutheran Church Foundation Board, the First Judicial District Ethics Committee and the Dakota County Bar Association Board. Sheldon also serves in the Burnsville Rotary.



Bill Middlecamp, Apple Valley, is seeking election in District 2, and is a 25-year Dakota Electric member. He is a software engineer for Quantum Corporation. He has served in leadership at Cray Research, Nemadji Research Corp.,

The Well United Methodist Church and several volunteer organizations. He is a commissioned United Methodist Earthkeeper. Middlecamp has two years of electronics training, Bachelor of Science degrees in computer science and meteorology, and a Master of Science in computer science from the University of Wisconsin, Madison. District 3

District 4



Paul Trapp, Hastings, is the incumbent seeking re-election in district 4. A Dakota Electric member since 1970, Trapp became a board member in 2001. He is the board secretary and secretary of Midwest Energy Services. He is a member

of the Scholarship Committee and has received the National Rural Electric Association's three highest leadership awards. Trapp has served as chair of Dakota Electric's Election Committee and member of the Audit, Capital Credit and Bylaw Review committees. He is the third generation to operate his family's farm. Trapp has

represented Dakota Electric in St. Paul and Washington D.C. He was also serving on the board when it approved the first electric vehicle charging rate in Minnesota for Dakota Electric members.



Stacy Miller, Eagan, is seeking election in District 4, and is a three-year Dakota Electric member. Miller works for the city of Minneapolis as a sustainable energy coordinator, where she helps develop sustainable energy and electric vehicle initiatives. She has served with various
