# **About our rates**

# Dakota Electric plans to file a rate case

Dakota Electric plans to file a rate case with the Minnesota Public Utilities Commission (MPUC) seeking permission to increase overall electric utility revenue by about 4.3%.

#### **Review process**

The Minnesota Department of Commerce – Division of Energy Resources and the MPUC will review Dakota Electric's rate filing and examine our records.

#### Interim rates

State law allows us to collect higher rates on an interim basis while our rate filing is reviewed. If the MPUC approves our request for a 3.0% interim increase, the additional charge will apply to electricity use beginning in November, for which members will begin receiving bills in December.

The interim increase will remain in effect until the MPUC determines final rates. If the approved overall total increase is lower than interim rates, we will refund members the difference with interest. If the overall total increase is higher, we will not charge members the difference.

The monthly bill for a typical residential member using 700 kilowatt-hours of electricity will increase about \$2.85 as a result of the proposed interim increase, which will appear on bills as "Interim Rate Adjustment."

For residential and small general service members, the interim adjustment applies to the monthly fixed charge, energy charge and resource and tax adjustment. The interim adjustment also applies to the demand charge for commercial members.

#### Member involvement

Members may comment on the proposed final increases at public hearings that will be scheduled by an administrative law judge from the MPUC. Dakota Electric will provide details about the hearings in local newspapers, a bill insert and on our website. Members may also provide written comments about the rate increase to the MPUC. Instructions for written submissions will appear in a future bill insert and on our website.

# **INCREASING COSTS**

Since Dakota Electric's last request for a rate increase in 2014, cost for equipment, labor and materials have continued to increase. These factors, combined with minimal growth in electric sales in the last five years, contributed to the need for this filing.

# **Community Programs**

"Safety" is a serious issue that is regularly discussed at Dakota Electric. In fact, it is our number one priority.

This is not empty talk. Over time, Dakota Electric has created a culture of safety by putting our employees' safety, and that of the community, above all else. Because we live and work in the community we serve, we care about our neighbors.

Manager of safety services, Brandon Lunde, promotes safety education in our schools and local communities through electrical safety programs and safety camps. Play It Safe Around Electricity teaches children eight and older about the dangers of electricity in a fun and interactive way.

Additionally, Dakota Electric's power line safety demonstration dives deeper into the risks associated with electrical safety and how it plays out in our daily lives. We provide this program for public safety personnel, contractors, farmers, and other community organizations and clubs. On average, we performs 20-30 safety demonstrations each year and reach an average of 1,500 to 2,500 people.

Our duty and responsibility is to raise awareness about the importance of electrical safety in the community. # **Update**

Installation of the first 5,000 meters, in and around Farmington, Lakeville and rural Hampton, began the last week of September and will continue throughout the month of October. Members receiving an upgraded meter were mailed a postcard mid-September stating that Dakota Electric contractors will be knocking on their door to install meters within the following weeks. After the installation, members will receive a door hanger informing them that their meter was changed.

These first 5,000 meters will help us test how the communication system and integration works before we install the remaining meters in 2020 and 2021. Not all members in and around Farmington, Lakeville and rural Hampton will receive an upgraded meter at this time.
