# Wall Street Journal features Dakota Electric members

South of Farmington sits 15 acres of farmland producing enough energy to power around 600 homes. The land, owned by Dakota Electric members Dick and Jane Nielsen, will deliver more than 5 million kilowatt-hours of energy each year to members of Dakota Electric.

About 10 years ago, Dakota Electric started looking at ways to provide more renewable energy for its membership. At the same time, interest in solar power grew and net farm income dropped, leaving farmers searching for alternative revenue streams.

Farmers leasing their land to generate energy revenue is what brought a reporter from the Wall Street Journal to feature the Nielsens in the Sept. 23 article, "Struggling Farmers See Bright Spot in Solar." The journalist, Kirk Maltais, contacted St. Paul nonprofit Fresh Energy to learn more about rural solar projects.

The article features an in-depth look at why the couple leased their land for the solar panels, as well as a few photos of the Nielsens at the solar site.

Dakota Electric CEO Greg Miller is proud to see the Nielsens featured and believes that Dakota Solar 4 is mutually beneficial.

"We work hard to ensure that each project we build is in the best interest of our members and the cooperative," Miller stated. "The new solar site is a win-win for all involved." Dakota Solar 4 is the largest solar project Dakota Electric has commissioned, with over 10,300 panels that will produce more than 5 million kWhs of power annually. This is in addition to our wholesale power supplier Great River Energy's commitment to achieve 50% renewable energy in our fuel sources portfolio by 2030.

Dakota Electric worked with Great River Energy and ENGIE (formerly SoCore Energy) to construct the three-megawatt solar project on the Nielsen's land.

ENGIE owns the solar facility on behalf of Great River Energy. Through a power purchase contract with Great River Energy, Dakota Electric purchases all the solar output for delivery to its member-owners. The project is planned to be commercially operating in early 2020.

Like the first two solar projects near Hastings and Randolph, Dakota Solar 4 will be planted with pollinator-friendly native flowers and grasses. In a couple years, the habitat will generate an abundance of healthy food for bees and other insects, providing critical services to our food and agriculture system.

Dakota Electric's four solar projects combined will deliver more than 9 million kWhs of solar energy annually to Dakota Electric members — enough energy to power approximately 1,100 homes.

### Clean out the gutters.

Fall leaves and debris left in gutters over winter can clog drains, which can potentially cause ice dams and lead to your drainage systems not working properly. This can lead to water seeping into your home and all sorts of issues and extra energy costs.



### Show some TLC to your furnace.

Have your furnace annually inspected each autumn. Sediment buildup can cause your system to work less efficiently or potentially become a fire hazard. During the winter, change your filter regularly; a dirty filter will decrease air flow and energy efficiency.



### Rule your attic.

sealing air leaks around your home and adding insulation are two of the most cost-effective ways to improve energy efficiency and comfort in your home. By tackling both projects, you can maximize your comfort and save up to 10% on your annual energy bills.



### Turn down your tank's temperature.

Water heating is the second largest energy expense in your home. It typically accounts for about 18% of your utility bill after heating and cooling. Lower the temperature on your water heater to 120°F; for every 10°F reduction in temperature, you can save from 3%–5% on your water heating costs.



### Winterize your habits.

Turning back your thermostat 7-to-10 degrees for 8 hours a day can save up to 10% on heating costs. If you set your temperature to 68 degrees while at home and lower the temperature before going to bed, your HVAC system will have less work to do, resulting in lower energy consumption.



### Light the way.

Whether decorating for the holidays or creating a warm atmosphere in your home, choose ENERGY STAR® certified decorative light strings. These holiday lights use 75% less energy than conventional incandescent



#### Be smart in the kitchen.

The average American home uses 15% of its energy in the kitchen. Ceramic or glass dishes conduct heat more efficiently, allowing you to turn your oven temperature down by about 25 degrees.

# Affordable energy-efficient upgrades for income-eligible members

To help members with limited financial resources, Dakota Electric spends approximately \$200,000 each year partnering with local organizations such as the Community Action Partnership of Scott, Carver and Dakota counties (CAP) and the Community Development Agency (CDA).

Michelle Polson, housing program manager at the CAP Agency in Rosemount, explains the organization and services available for the energy assistance program.

### **Explain the CAP Agency and what you do:**

The CAP Agency is a local nonprofit organization that works to stabilize individuals and families experiencing crisis. We assist and empower people to achieve social and economic well being by providing them with the necessary resources needed for self reliance.

As for what I do at the agency, I oversee our Conservation Improvement Program (CIP) and affordable housing units, which are primarily located in Dakota County and some in Scott County.

#### **Describe your partnership with Dakota Electric:**

As a longtime partner of the CAP Agency, Dakota Electric provides funding and support for our CIP program. Working with Dakota Electric has made a big impact in our community and neighborhoods. The partnership allows us to have a program that helps with saving energy on a larger scale.

# How do you use the funds you receive from Dakota Electric?

With support from Dakota Electric, we perform energy audits and provide households with new ENERGY STAR® appliances, such as washing machines, refrigerators,

electric water heaters and more. Appliances must be over 10 years old to qualify. These households are then able to save money on energy costs and direct those savings to other urgent costs such as food and housing.

### What are the eligibility requirements?

To qualify for the CIP program, a household must be under 200% of the Federal Poverty Income Guidelines. Eligibility is determined by using the past three months of the homeowner's household income prior to signing the application, or last year's federal tax forms for self employment. This means that a family of four must have an annual income of less than \$51,500 in order to qualify.

### How do people apply?





# **Download our outage app**




- **1.** Download and install the free outage app by visiting the App Store or Google Play on your mobile device and search for "Dakota Electric" (made by MTS Systems).
- **2.** Once installed, you must request a code by calling 651-463-6212 or submitting a form online. The code is specific to your account and is required to personalize the app to your residence.
- **3.** Once you receive the code, tap the symbol in the upper left corner of the dashboard screen in the app, type in the code and hit "Subscribe." You can now set up your profile and alert notifications.

# Rate case update

Dakota Electric submitted a general rate case petition to the Minnesota Public Utilities Commission on Sept. 19, 2019, requesting an overall annual revenue increase of about 4.3% or \$8.7 million.

The filing includes an interim increase while our general rate case is being reviewed. A 3.0% increase will apply to electricity use beginning in November 2019, for which members will begin receiving bills in December 2019. This interim increase appears on your bill as "Interim Rate Adjustment."

State agency regulatory staff is now reviewing the filing for procedural compliance. Like all general rate case filings, this filing is expected to be referred to the Office of Administrative Hearings for further review.
