Final electric rate increase is effective with electric use on and after Oct. 1, 2020

The change to your monthly electric bill will vary depending on the amount of electricity you use. Your monthly bill will also vary due to changes in the cost of wholesale power purchased by Dakota Electric Association for your use. The amount you are charged for wholesale power costs is the same amount Dakota Electric pays.

On Sept. 19, 2019, Dakota Electric filed an application with the Minnesota Public Utilities Commission (MPUC) for an electric rate increase of 4.3% annually or about \$8.7 million. Dakota Electric was allowed to charge an interim rate of 3%. The MPUC approved a total rate increase of 4.25% or approximately \$8.5 million. This is approximately 1.25 percentage points more than the interim rate charged to members.

Residential members will see a \$1 increase in the monthly fixed charge and the energy charges will increase from 13.33¢ to 13.77¢ per kWh during the summer months, and from 11.93¢ to 12.38¢ during other months. The overall average increase for residential members is 4.33%. Under the MPUC decision, electric rates changed for all member classes and are noted on the inside of this notice.

RESOURCE AND TAX ADJUSTMENT

While the majority of the Resource and Tax Adjustment was absorbed into the standard rate, members will continue to see a Resource and Tax Adjustment charge on their bill related to wholesale power in 2020. The 2020 Resource and Tax Adjustment rates were not included when Dakota Electric filed its rate increase application in 2019.

The chart below compares average interim and final electric bill increases by customer class. The final monthly increase amount includes the interim increase amount. The average residential member experienced a \$2.85 increase last year when the interim rates became effective and will see an additional \$1.28 increase for a total increase of \$4.13.
