

## 2022 Board Compensation

✓ A motion was made, seconded and carried with an 11-1 majority to approve the new director monthly compensation rate of \$2,840 effective June 2022.

## President and CEO Report

Vice President of Financial Services and CFO Corey Hintz provided an update regarding a change in check processing, long-term debt and delinquent accounts. Vice President of Information Services and CIO Mjyke Nelson provided updates related to the new board room equipment installation delay due to supply issues. CIO Nelson also reviewed the current status of ERP and mobile connectivity.

Vice President of Utility Services Jeff Schoenecker shared Dakota Electric's response to the recent MN Valley tragedy. He then reviewed Dakota Electric's message shared with our own linemen highlighting the importance of going slow and asking questions to ensure safety.

Vice President of Regulatory Services Adam Heinen provided updates regarding the legislative session, 2021 IDP and Dakota Electric's PUC filing to lower reconnect fees due to the ability to remote connect.

#### Great River Energy CEO Update

Great River Energy President and CEO David Saggau joined the meeting to discuss what Dakota Electric governance may look like post Connexus exit and answer questions.

## 2022 Post Election Wrap Up

Survey and Ballots representative Tony Hoff reviewed the results of the 2022 annual director election and highlighted trends in electronic voting. Mr. Hoff then provided recommendations for future consideration regarding social media content, expanding the voting period length and the ability to send SMS texts including personalized login links for every member who opts in.

#### President and CEO Report Continued

The President and CEO report resumed with Vice President of Energy and Member Services Jon Beyer providing an update related to commercial land development involving a beverage bottling manufacturing facility. A decision is expected by the beginning of June. Vice President Beyer also highlighted the success of the recent Ride and Drive event and discussed possible new commercial business. President and CEO Greg Miller then concluded with a safety update and reviewed post retreat plans noting staff's next steps with GreatCo-Ops.

#### 2022-2024 Corporate Insurance Resolution

A motion was made, seconded and carried to approve the 2022-2024 Corporate Insurance – Resolution 22-5-2.

#### **Great River Energy**

Directors Margaret Schreiner and Clay Van De Bogart provided a Great River Energy update regarding safety discussions, high natural gas prices due to the war in Ukraine, business improvements and approved resolutions.

#### Minnesota Rural Electric Association

Director Stacy Miller provided a Minnesota Rural Electric Association update and shared a suggested resolution drafted by herself and Director John DeYoe regarding energy cost disclosure for renters. She then shared a resolution drafted by John DeYoe regarding consumer metrics for EV vehicles noting their intent to submit both to MREA and NRECA for consideration.

#### **Attorney Update**

Attorney Sara McGrane provided an update noting work this month related to risk register concerns, wage equity survey, ERP software project and a non-disclosure agreement.

# Annual Fiduciary Duties of a Director Review

Attorney McGrane provided an annual review of director fiduciary duties highlighting the importance of following bylaws and policies, liabilities, duty of diligence, delegation of power and that duties are owed to the cooperative membership as a whole, not individual members.
