Charge smarter with Dakota Electric

Dakota Electric offers three convenient options for charging your EV at home, along with a \$500 rebate to help offset the cost of installing a charging circuit when you enroll in the storage or time-of-use programs.

Off-peak storage rate

Get the lowest cost for EV charging by powering up overnight. Electricity is available only during off-peak hours (11 p.m. to 7 a.m.), when demand is low and rates are too.

Time-of-use rate

Prefer flexibility? Charge anytime you like, with discounted rates during off-peak hours to help you save when the grid is less busy.

Virtual metered EV charging program

Skip the extra hardware. The virtual metered EV program makes it easy to take advantage of EV charging rates without needing to install another meter.

Install an electric water heater

Upgrade to an electric thermal storage (ETS) water heater to receive a rebate of up to \$400. You must enroll in the ETS water heater program to qualify for the rebate. Dakota Electric is now selling Marathon water heaters for at cost. For more information, visit www.dakotaelectric.com/member-services/programs-rebates or call our Energy Experts at 651-463-6243.

Install electric heating

There are many benefits to installing electric thermal storage (ETS) heating in your home. If you are considering electric heat for those hard-to-heat areas, purchase an ETS heating system and receive a \$50/kW rebate when you enroll in one of Dakota Electric's off-peak programs.

Sales tax exemption for residential heat

A tax exemption is available for the months of November through April if you heat your home primarily with electricity. To determine eligibility, see the Minnesota Department of Revenue Sales Tax Fact Sheet 157 at www.revenue.state.mn.us.

- **January 29, 2026 (afternoon/evening)** Director candidate interviews backup date (in-person at Dakota Electric Headquarters*)

*Interviews will take place in person, but accommodations for other suitable means may be granted to Director candidates due to extenuating circumstances.

Two members and one alternate member from each district will be selected at random from the pool of eligible member applicants. Selected member volunteers will be notified of the outcome following the Board meeting held on **December 11, 2025** and will also receive a handbook outlining Committee responsibilities. Those who serve on the Nominating Committee will receive a stipend for their time.

Looking for **energy- efficient** appliances?

EnergyStar is being phased out, but you can still find energy-efficient appliances for your home. Even without the EnergyStar label, look for the yellow Energy Guide label, which shows estimated annual energy costs and usage. You can also check the Consortium for Energy Efficiency (CEE) Tier List online to see which appliances meet high-efficiency standards.

Small changes at home can help you save energy and money, no matter the equipment you have. Adjusting your thermostat, keeping appliances clean, and checking fridge seals can all make a noticeable difference in energy use and costs.

Energy assistance available

Dakota County residents who need help paying their energy bills can apply for support through the Community Action Partnership (CAP) Agencies' Energy Assistance Program. The program helps eligible households with heating and utility costs during the colder months.

Rate case update

Dakota Electric's rate case remains under review by the Minnesota Public Utilities Commission (MPUC). As shared in previous updates, a Settlement Agreement was filed in June between Dakota Electric, the Minnesota Department of Commerce, and the Minnesota Office of the Attorney General. The agreement, if approved, would increase the cooperative's annual revenues about 9.62% or \$20.88 million.

The MPUC is expected to make a final decision in early 2026. In the meantime, the interim rate increase of 9.5% will remain in effect. If the approved overall increase is lower than interim rates, we will refund members the difference with interest. If the overall increase is higher, we will not charge members the difference for the interim period. The new rates will go into effect at the end of this case.
